# 1. INFORMATION

Československá trofej (ČST) is a common project under the cooperation umbrella of the Slovak (SAMŠ) and Czech (AČR) ASN with a goal of creating and alternative circuit racing opportunity for participants not participating in the official national championship events due to several reasons.

#### 2. ORGANIZER

**SLOVAKIA RING AGENCY s.r.o.**, based on the mandate of SAMŠ organizes the Československá trofej (ČST) racing event on the 22. – 23. April 2022 on the SLOVAKIA RING circuit.

The races which are part of the national calendar will be organized in accordance with:

- National sporting code SAMŠ
- Standard circuit racing provisions SAMŠ 2022
- SAMŠ 2022 Yearbook
- These Supplementary regulations

#### 4. RACETRACK CHARACTERISTICS

The race will be organized on the SLOVAKIA RING racetrack with a valid FIA Grade 3 license.

In case limits are exceeded, the entry forms will be accepted based on their acceptance dates.

#### Race characteristics:

- a) Number of free trainings: 2 during the second day of the event
- b) Number of qualifying trainings: 1 during the second day of the event
- c) Number of races: 2 during the second day of the event
- d) Each driver must have a valid time at least from the qualifying to be allowed to participate in the race. In case a valid track time is not achieved, a driver can request for an approval to start in the race. The cases will be discussed by the race jury.
- e) The starting grid for both races will be made according the best laptimes from the qualifying.

# 5. DRIVER LICENSE REQUIREMENTS

Each driver must have valid national circuit license or an approved daily license.

# Lights:

All vehicles must be equipped with 2 front lights and 2 red rear lights, rain lights and turn signals. The front lights must be yellow or white colour.



# **Driver safety equipment:**

**Helmets** are mandatory according to the standards: SNELL: SA2010, SAH2010 resp. FIA: 8858-2002, 8858-2010. **Driver equipment:** overall, laundry, balaclava, gloves, shoes min. according to the standards FIA: 8856-2000. **FHR:** Hans or hybrid systems according to the standards FIA: 8858-2002 or 8858-2010.

#### Car safety equipment:

Fuel tank: serial or FIA homologated FIA (FT3 1999, FT5, FT3.5)

Seat: with a homologation at least FIA 8855-1999 or seat according to annex J art. 253 or TI AČR 06/2016

Seat belts: min. 6-point FIA standard seat belts with fixation acc. to annex J art. 253

Fire extinguishers: mandatory acc. to annex J art. 253

# 13. TRAININGS, QUALIFYING AND RACES

**Paid training sessions:** will be organized during the first day of the event in 30 min sessions for each class separately. The paid training sessions are not included in the entry fee.

**Trainings:** 2 trainings for each class á 25 min during the second day of the event.

**Qualifying:** 1 qualifying for each class á 25 min during the second day of the event. Based on the qualifying laptimes the starting grid will be prepared for both races.

Races and procedures: For both classes 2 races will be organized á 25 min during the second day of the event. 5 minutes before the PIT EXIT OPEN are all competitors obliged to prepare in the pitlane in the starting gird order. Safety car will lead the cars from the pitlane to the formation lap where all cars will have to follow each other in the required positions based on the starting grid. By the end of the lap the safety car will leave the track and the racing cars continue to the main straight (no stopping on the starting grid). As soon as the safety car leaves the racetrack green lights will be signalized but racing is only allowed after the finish line is crossed. The race time starts when the first car crosses the finish line for the first time. The race is finished with a chequered flag in the moment when the leading driver crosses the finish line after the time of the race is passed.



# 14. TIMEKEEPING

Each vehicle must use a transponder from timekeeping received from the organizer. The competitor is responsible for the installation and functionality. The transponder is mounted according to the instructions. In case of damage or loss the competitor must pay a fine of 450 EUR.

# 15. SPEED IN PITLAN AND PADDOCK

The maximum allowed speed in the pitlane is limited to 60 km/h, in the paddock is the speed limited to 30 km/h. Speeding will be fined with 20 EUR for each kilometre above the limit.

#### 16. SAFETY CAR

During the races a safety car can be deployed for neutralizing the race in accordance with art. 2.9 annex H of the FIA international sporting code. The safety car will be used also by the start of the race.

#### 17. PRIZES AND PRIZEGIVING CEREMONY

The prizes will be awarded to the first three drivers after each race on the podium, for the overall winners and the winners of each class. The riders are obliged to participate in the ceremony. In case 4 or less cars are participating in a class, only the winner of the qualifying will be awarded.

#### **18. INSURANCE**

According to the legal rules the event is insured in the Kooperativa Vienna Insurance Group a.s. company, number of the insurance 6574436169. The insurance covers the third-party damages up to 233.000 EUR.

# 19. LANGUAGE

Supplementary regulations are prepared in Slovak an English language. The final version in the Slovak language on and in case of differences in interpretation the Slovak language is decisive. The titles used in these regulations are only referential and informative.

#### 20. PADDOCK

Paddock is located within the SLOVAKIA RING area. Entry and leaving the paddock is allowed only for vehicles with proper authorization. For each vehicle a separated place is located within the paddock. Any commercial activity within the paddock is allowed only based on a formal allowance by the organizer. All traffic signs must be respected. The speed is limited to 30 km/h. Drifting is permitted. All competitors must respect the local trash disposal rules. The transportation trailers must be parked in the separated area outside of the paddock. All organizer staff instructions must be respected. Drilling in the paddock is forbidden. Every motorized vehicle must be driven or ridden only by adults. Each violation of the above-mentioned rules can be fined. All competitors must respect the operational rules of the facility.

#### **21. BOXES**

Boxes can be reserved via email <a href="mailto:raceoffice@slovakiaring.sk">raceoffice@slovakiaring.sk</a>.

The competitors must move into their boxes on the 22.4.2022 till 14:00 latest. In case the box is not occupied till the time mentioned, the box registration can be cancelled.

Price for the box rental is 240 EUR for the whole event. Deposit for the box key is 100 EUR. The boxes and paddock must be emptied on the 23.4.2022 till 19:00 latest. In case of any damages in the boxes the deposit will not be returned.



# 22. SERVICE ROADS

Entering the service roads is allowed for accredited media only and for officials with a valid authorization. Entering the service road without a valid authorization can be fined.

#### 23. PROTESTS

Protests are managed in accordance with the Art. 13 FIA sporting code. The protest fee is 500 EUR. The national appeal fee is 1.340 EUR, the international appeal fee according to the FIA sporting code.

#### 24. OTHERS

**Driver insurance** – each driver is obliged to have a personal health insurance.

Signalization – according to the annex H FIA international sporting code

Fuel – only fuel accepted by the annex J FIA international sporting code or national sporting code

Industry zone – for the tyre suppliers will be marked, price for a supplier is 500 EUR

**Firefighting precautions** - It is forbidden to smoke, manipulate with open fire, use grills in the boxes, pit lane and up to the line in the paddock in each time. The infringement of this precautions will be sanctioned with 250 EUR for every infringement.

**SLOVAKIA RING** area - In the SLOVAKIA RING complex is forbidden to behave in a manner that jeopardizes the security or order, or with unreasonable noise disturbing other participants of the event. In the SLOVAKIA RING complex is forbidden to drive racing cars, tune the engine or cause unreasonable noise after 22:00 until 06:00. Access to the Pit Lane and starting grid is strictly forbidden to persons without any special sign and persons younger than 16 years.

#### 25. COVID-19 PRECAUTIONS

The organizer of the event reserves the right to change the propositions and rules depending on the currently valid regulations of the Government of the Slovak Republic and the recommendations of the Slovak Motorsport Association (SAMŠ) regarding the organization of public sports events. Participants are obliged to comply with these regulations and, if necessary, to tolerate inspections depending on current developments and the abovementioned regulations of state authorities. All COVID-19 rules that will be published on official notice board and riders and teams will receive it via email or at administrative check.
