

Regulations

Article 1.

ENTRIES AND ENTRY FEE

Send a duly completed application form signed by the driver and the parent club to the e-mail (*office@sakss.org.rs*) by April 29, 2025.

The original application form must be attached to the verification of the competition.

Complete and non-certified application forms will not be accepted.

Organizer will send confirmation of the receipt of entry by e-mail to the e-mail stated in the entry form.

Possible changes to application information must be sent to the Organiser no later than 48 hours before the start of the competition.

The entry fee can be paid to:

The entry fee for all classes per day is 12,000.00 dinars.

The entry fee for all classes of the FIA CEZ Championship is $\pounds 276.$

The organizer reserves the right not to accept drivers who do not send timely applications and drivers who send incomplete applications. The organizer reserves the right to allow these drivers to participate in the race with a 50% increased entry fee.













Organiser will inform the participants in case of the cancellation of the Meeting in case of Force Majeure. In the case of cancellation of the event the already paid entries will be returned.

Article 2.

ELIGIBLE PARTICIPANTS

Drivers will be allowed to participate if they meet the requirements of the SAKSS regulations. The drivers must hold valid national driving license, valid insurance and medical certificate of aptitude valid for 2025.

Article 3.

ACCREDITATION

Each driver will receive one pass for mechanic that will be allowed to enter Parc Ferme.

Article 4.

CLASSES

<u>FIA Central European karting Championship (CEZ)</u> will only be held on May 4, 2025 in the following Classes: OK, OK Junior and KZ2 - acc. FIA Karting regulations

Rotax Micro MAX, Rotax Mini MAX, Rotax Max Senior, Rotax Max Junior, DD2 and DD2 Masters - according the regulations of the Global Rotax MAX Challenge regulation and some additional provisions specified in these regulations.

National championship of Serbia, Serbian open championship and Republic of Srpska championship will be held in the following Classes:

Class I – Rotax Micro MaxClass II - Rotax Mini MaxClass III - Rotax Max JuniorClass IV- Rotax Max SeniorClass V – Mini TalentClass VI – KZ2Class VII – KZ2 MasterClass VIII – T&G MasterThe technical rules from Appendix A – technical requirements for karts for 2025 apply to

The technical rules from Appendix A – technical requirements for karts for 2025 apply to all classes.

Article 5.

CLASSIFICATION AT THE EVENT AND SCORING OF POINTS

For each class three races will be held. Starting grid for the second race will be defined by the classification in the first race, while the starting grid for the third race will be defined by the classification in the second race. In each race drivers will score points in the following manner:

All scored points will be awarded for the FIA CEZ Karting championship.

The number of starters are defined based on at least one heat on the event that counts for the final classification.

All scored points will be awarded for the National championship of Serbia.

If there are less than 3 starters = ½ points will be allocated.

If there are less than 2 starters = no points will be awarded.

For all championships, points will be awarded in accordance with the Appendix to the 2025 Kart Racing Regulations.

The classification at the event will be obtained by sum of points from all races. If two drivers have the same number of points the driver who was better in Qualifying will be in front.

Article 6.


TRACK

Article 7.

STARTING NUMBERS AND STARTING PLACES

Starting numbers are determined according to the Article 13 of the SAKSS Regulations. New drivers must pick their number in coordination with the organizer of the event.

Starting places will be determined from Qualifying practice or Qualifying heats based on Article 2.17 and 2.19. of the FIA General Prescriptions 2025.

Article 8.

Schedule (Programme) is integral component of these Supplementary Regulations (provided at the beginning).

Article 9.

RACES

Races will be held according to the FIA General prescriptions for 2025 (Articles 2.19 – 2.24) and SAKSS Addendum to the Kart Racing Regulations for 2025.

Article 10.

START

Regulations of the FIA General prescriptions for 2025 (Article 2.20a) and SAKSS Addendum to the Kart Racing Regulations for 2025 (Article 18).

Article 11.

SIGNALING

During practices and races signalization defined by FIA General prescriptions for 2025 applies (Article 2.15) and SAKSS Addendum to the Kart Racing Regulations for 2025 (Article 18).

Article 12.

TECHNICAL REQUIREMENTS FOR THE VEHICLES

All karting vehicles must comply with the technical regulations for Central European Zone Championship and SAKSS Appendix A - technical conditions of karting vehicles for 2025.

On the event the minimum diameter of the main jet is:

Article 13.

CONDITIONS FOR TIRES

All vehicles must have tires in accordance with the technical regulations for Central European Zone Championship and SAKSS Appendix A - technical conditions of karting vehicles for the year 2025

FUEL

All competitors must use fuel in accordance with the regulations defined in SAKSS Appendix A - technical conditions of vehicles for karting races for the year 2025.

The fuel that will be used is unleaded gasoline 95 from the LUKI OIL pump - 121 Pećinci.

Article 15.

PENALTIES

Penalties will be imposed in accordance with the SAKSS Addendum to the regulations for karting races for the year 2025 (Article 27).

Article 16.

PROTESTS AND APPEALS

For all protests and objections, the regulations from the SAKSS Supplement to the Rules for Karting Races for 2025 will be applied (Article 26).

Article 17.

PRIZE GIVING

Prize giving ceremony will take place according to the Programme. The cup will be awarded for the first three in the ranking of the CENTRAL EUROPEAN ZONE CHAMPIONSHIP

in each class and Serbian Championship.

Article 18.

PADDOCK

Paddock will be open from 8:00 a.m. on May 3, 2025. and will close at 8:00 p.m. on May 4, 2025. year.

Each driver will receive garbage bags at the administrative check in. After leaving the paddock all garbage has to be placed in bags and leaved in the area designated for garbage. The area will be marked on the circuit layout.

Non-permeable and non-wet mats are mandatory for all karts (in case someone does not comply with this rule, they will be removed from the competition without the possibility of returning the registration fee).

Any drilling or damage to the existing surface (asphalt) in the pit is strictly prohibited.

It is strictly forbidden to have open fire in the paddock at any time. The fine is 250 € for the first offence and exclusion from the event for the second.

Article 19.

RESPONSABILITY FOR THE DAMAGES CAUSED

Drivers and mechanics bear full responsibility for material and personal damage caused in the paddock and on the track during the Meeting.

Organiser does not accept responsibility for drivers for personal injury and damage done to themselves, third parties, vehicles or objects.

Organizer accept responsibility for vehicles at the time they are placed in Parc ferme.

Article 20.

LEGAL RESPONSABILITY

By participation in the competition, every driver and competitor disclaim the right of any complaint in connection with the possible accidents that might befall them or their assistants during practices and/or races, or on the way from the Service park to the track and back. This waiver applies in relation to FIA, CSAI, and organizer of the Meeting SAKSS, all the officials and other participants (drivers and their assistants).

Driver is responsible for all possible violations of FIA and/or CSAI regulations, both in his own name and in the name of his mechanics and any other persons which are in any way related to his appearance at the competition.

Article 22.

KNOWLEDGE OF THE SUPPLEMENTARY REGULATIONS

Drivers and competitors by signing the Entry form declare that that they have read and accepted the terms in this supplemental regulations and that they are informed with the terms of all Regulations mentioned in the introductory part of these Supplementary Regulations – fragment "ORGANISATION".

By signing the Entry form, voluntary and unambiguously, a driver gives consent to processing and use of the personal data in accordance with GDPR (EU) 2016/679, with the purpose of conducting the sporting competition in question.



















Article 23.

FINAL APPOINTMENTS The Organiser reserves the exclusive right of amendments and changes of the Supplementary Regulations (information, bulletins), and to postpone or cancel the Meeting in case of Force Majeur, and participants will be timely informed.
